Join the conversation! Facebook.com/SHPNC Please note: Section 1512 of the Affordable Care Act (ACA) requires applicable employers to provide all employees with written notice of the following:

- the existence of the Marketplace (referred to by the ACA as the Exchange);
- potential eligibility for premium tax credit under 36B of the Internal Revenue Code if the employee purchases a qualified health plan through the Marketplace;
- and loss of employer contribution for the purchase of a qualified health plan through the Marketplace.

This notice must be provided to all employees by October 1, 2013, and to all new hires thereafter. The State Health Plan communicated earlier this year that it would be able to assist in providing this notice to employees; however, upon review of the recently released notice, the State Health Plan determined it will be <u>unable</u> to issue this notice to employees.

The notice requires information specific to each employing unit, and the State Health Plan does not have this information. In addition, the notice is required to be sent to all employees, not just those participating in the Plan. The Plan does not have contact information for employees who are not enrolled with the Plan. As such, each Employing Unit will be responsible for meeting this notice requirement.

The information must be provided to the employees before October 1, 2013. The template is available here, and highlights the customizable sections.



New Health Insurance Marketplace Coverage Options and Your Health Coverage

PART A: General Information

When key parts of the health care law take effect in 2014, there will be a new way to buy health insurance: the Health Insurance Marketplace. To assist you as you evaluate options for you and your family, this notice provides some basic information about the new Marketplace and employment-based health coverage offered by your employer.

What is the Health Insurance Marketplace?

The Marketplace is designed to help you find health insurance that meets your needs and fits your budget. The Marketplace offers "one-stop shopping" to find and compare private health insurance options. You may also be eligible for a new kind of tax credit that lowers your monthly premium right away. Open enrollment for health insurance coverage through the Marketplace begins in October 2013 for coverage starting as early as January 1, 2014.

Can I Save Money on my Health Insurance Premiums in the Marketplace?

You may qualify to save money and lower your monthly premium, but only if your employer does not offer coverage, or offers coverage that doesn't meet certain standards. The savings on your premium that you're eligible for depends on your household income.

Does Employer Health Coverage Affect Eligibility for Premium Savings through the Marketplace?

Yes. If you have an offer of health coverage from your employer that meets certain standards, you will not be eligible for a tax credit through the Marketplace and may wish to enroll in your employer's health plan. However, you may be eligible for a tax credit that lowers your monthly premium, or a reduction in certain cost—sharing if your employer does not offer coverage to you at all or does not offer coverage that meets certain standards. If the cost of a plan from your employer that would cover you (and not any other members of your family) is more than 9.5% of your household income for the year, or if the coverage your employer provides does not meet the "minimum value" standard set by the Affordable Care Act, you may be eligible for a tax credit.\frac{1}{2}

Note: If you purchase a health plan through the Marketplace instead of accepting health coverage offered by your employer, then you may lose the employer contribution (if any) to the employer-offered coverage. Also, this employer contribution -as well as your employee contribution to employer-offered coverage- is often excluded from income for Federal and State income tax purposes. Your payments for coverage through the Marketplace are made on an after-tax basis.

** Even if your employer intends your coverage to be affordable, you may still be eligible for a premium discount through the Marketplace. The Marketplace will use your household income, along with other factors, to determine whether you may be eligible for a premium discount. If, for example, your wages vary from week to week (perhaps you are an hourly employee or you work on a commission basis), if you are newly employed mid-year, or if you have other income losses, you may still qualify for a premium discount.

If you decide to shop for coverage in the Marketplace, **HealthCare.gov** will guide you through the process. Here's the employer information you'll enter when you visit **HealthCare.gov** to find out if you can get a tax credit to lower your monthly premiums.
