# Regular Session Board Meeting December 14, 2020

The Gates County Board of Education met in regular session on Monday, December 14, 2020 through a remote meeting using the Zoom format. This was agreed to by the board members in order to follow safety guidelines. Chairman Ray Felton called the meeting to order at 9:00 a.m. The following board members were present: Mr. Ray Felton, Mrs. Glendale Boone, Mr. Leslie Byrum, Mrs. Sallie Ryan and Mrs. Amanda Pacitto.

Cathy Riddick, Notary Public, administered the oath of office to Mr. Ray Felton. Mr. Felton was duly elected in the March, 2020 election.

Chairman Felton asked Dr. Barry Williams, Superintendent, to proceed with the nominations for chairperson and vice chairperson of the board.

Dr. Williams then opened the floor for nominations for the position of chairperson of the Board of Education. Mrs. Sallie Ryan nominated Mr. Ray Felton for the chairperson position. Mrs. Glendale Boone seconded the nomination. Mrs. Glendale Boone then made a motion to close the nomination and Mrs. Sallie Ryan seconded the motion. There was no discussion and the motion carried unanimously. A call for vote for chair of the Board of Education was made by Ms. Cathy Riddick, Clerk to the Board.

Congratulations to Mr. Ray Felton as Chairman, and Mrs. Glendale Boone as Vice Chair.

Mrs. Glendale Boone made a motion to enter into closed session to discuss personnel as outlined in North Carolina General Statute 143-318.11(a)(6). Mrs. Sallie Ryan seconded the motion. Chairman Felton called for a vote. Board members stated their vote, and the motion carried unanimously. Board Members entered into closed session at 9:08 a.m.

#### **Items for Information:**

During the Superintendent's Report, Dr. Williams introduced Dr. Jared Miller with Sentara Healthcare. Dr. Miller spoke about safety protocol for our student athletes. He stated that they have put strict measures in place to deal with positive tests, to keep the athletes and the community safe. Success depends on the athletes being honest about exposure and symptom reporting. Dr. Williams and the board thanked Dr. Miller.

During the Board Report, board members thanked the teachers and staff for their dedication to our students and all the work they have done over the past several months. Everyone has done a great job. Included in that thank-you are all the departments, maintenance, food program, and transportation. Everyone has stepped up to the challenge. Mr. Felton thanked Dr. Williams for an outstanding job. Through connections he has made in Raleigh, he was able to secure a \$2500 grant for the schools, and has worked tirelessly behind the scenes to help Gates County Schools be successful.

Mrs. Sandra Pittman, Finance Officer, gave the Financial Report and provided an update on New Beginnings Daycare and Out-of-District Tuition.
